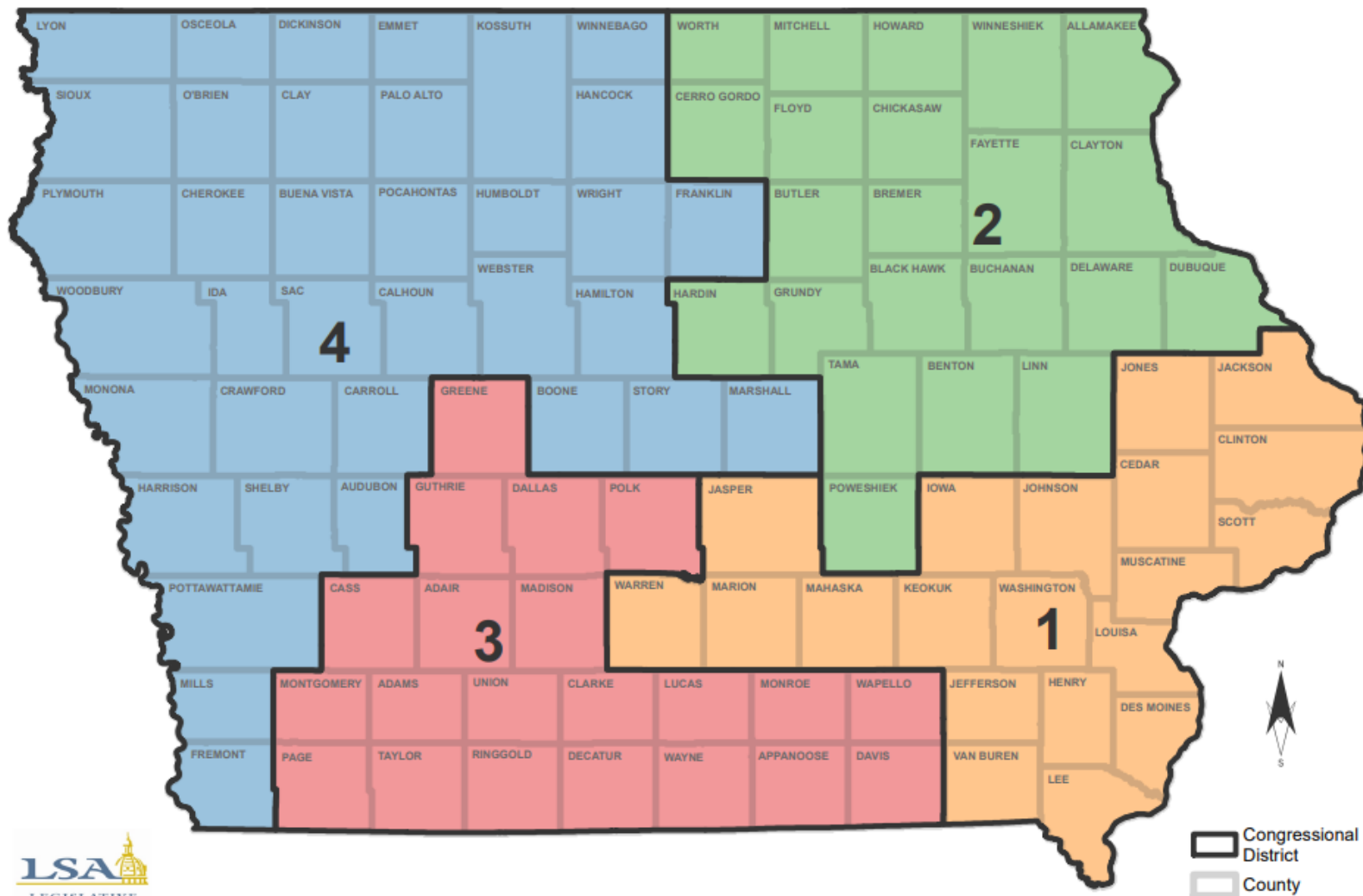

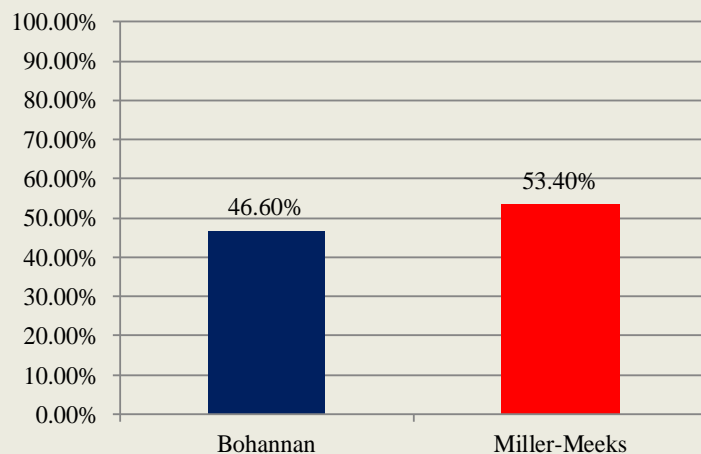

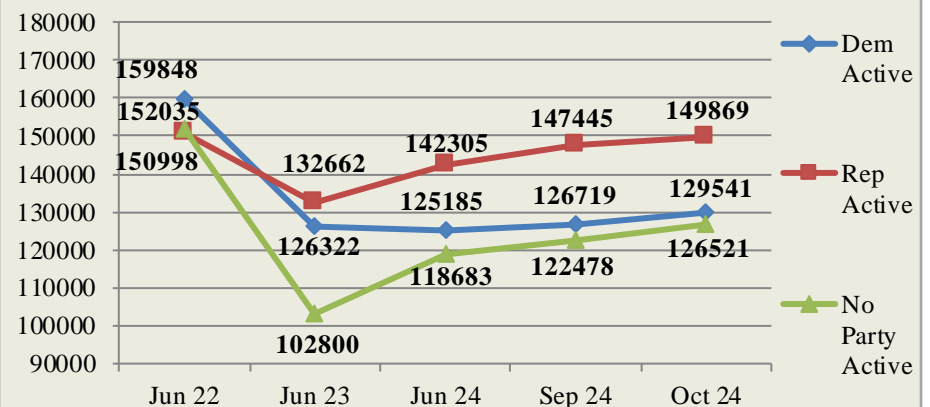

Congressional District 1**



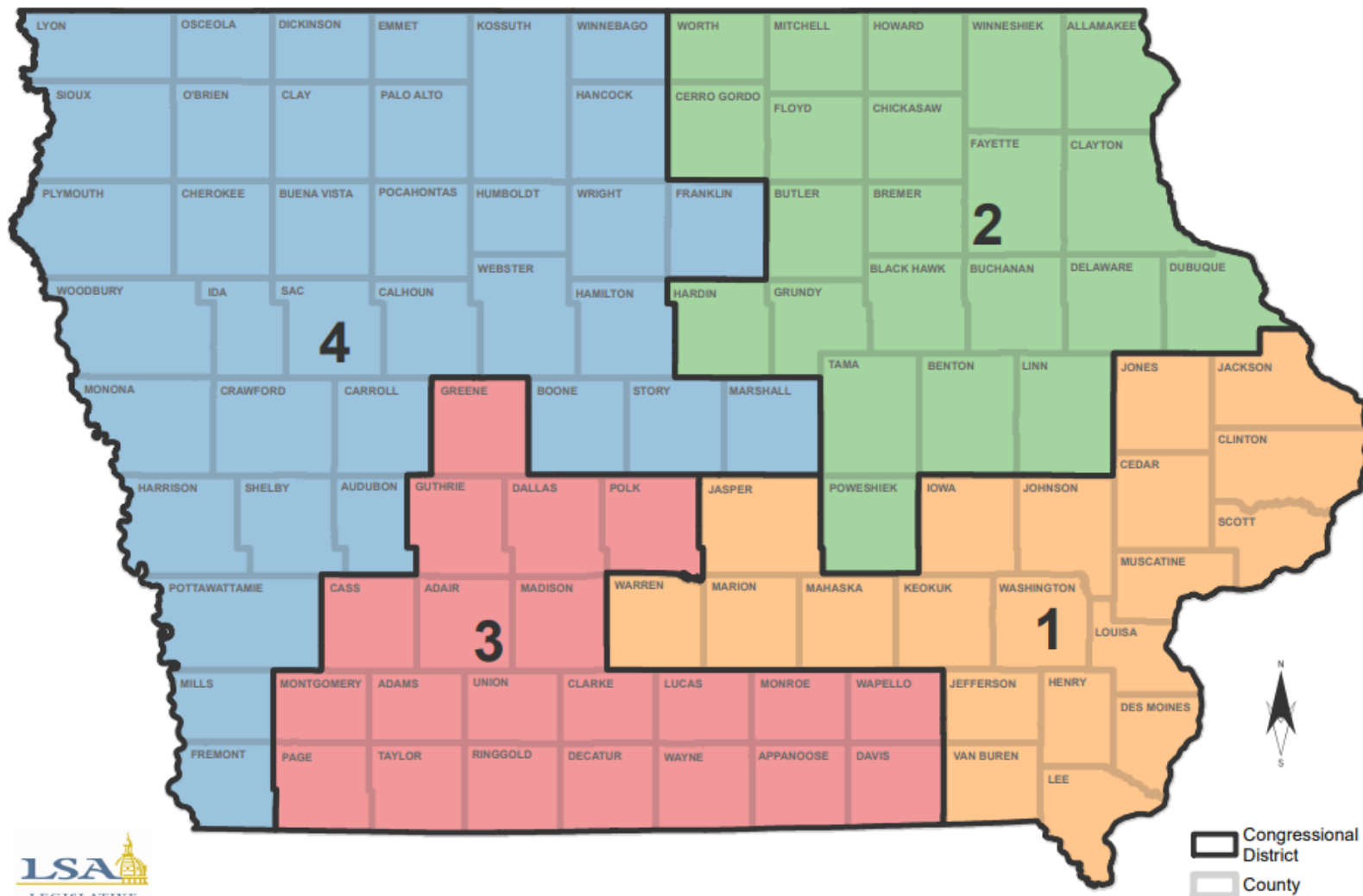
